Kibaale District Local Government has received funds from the Central Government and intends to use part of the funds for the provision of the Following works and supplies;

- 1) Construction of Kabasekende Water Supply System Phase two in Kabasekende Rural Growth Centre in Kabasekende Sub County (Re-advertised)
 - 2) Supply and delivery of mortuary fridge and Dissecting table for the mortuary at Kibaale Health Centre iv in Kibaale Town Council
- a) Kibaale District Local Government now invites sealed bids for the provision of the Works mentioned above.
 - b) Bidding will be conducted in accordance with Open Domestic Bidding procedure contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act 2003, the LG (PPDA) Regulations 2006 and the LG (PPDA) guidelines 2008

On the same day, all bids/applications will be opened in the Planning Unit Boardroom starting at **11:45 am** in the presence of bidders or their representatives who may choose to attend.
 - e) Bidders are required to submit 3 hard copies (1 original and 2 copies) and one soft copy of the bid.
 - f) All bids must be accompanied with a bid security in form of Bank Guarantee of **UGX. 18,900,000/=** (Eighteen Million, Nine Hundred thousand Uganda Shillings only) for item (1) and **1,314000/=** for item (2)
 - g) Late bids/applications shall be rejected.
